Whereas, the Government in Urban Development Department vide order No. 27<sup>th</sup> February 2009, had issued directives under Section 37(1) along with Section 154(1) of the Maharashtra Regional and Town Planning Act, 1966(hereinafter referred to as "the said Act") in respect of additional F.S.I. for buildings of Biotechnology Unit/Park subject to payment of premium.

And whereas, the incentives for Information Technology Parks are applicable for Biotechnology parks as per policy of Biotechnology parks;

And whereas, the Government in Urban Development has included revised provisions in respect of buildings of Information Technology including rate of premium vide Notification dated 15<sup>th</sup> July 2016, as per revised Information Technology-2015 in the Development Control Regulation of Municipal Corporations/New Town Development Authorities, Municipal Councils/Nagar Panchayats and Development Control and Promotion Regulations for Regional Plan areas in the State and vide Notification dated 26<sup>th</sup> July 2016 in the Developments Control Regulations of Maharashtra Industrial Development Corporation as a Special Planning Authority;



And whereas, the Government in Industry, Energy and labour Department has requested to issue further orders in respect of the rate of premium regarding additional F.S.I. for buildings of Biotechnology Parks, which are 25% of the land rate of Annual Statement of Rates and in case of buildings of Information Technology, 10% to 30% of the land rate of Annual Statement of Rates, as per amended provision of Development Control Regulations for Municipal Corporations/New Town Development Authorities / Municipal Councils/Nagar Panchayats/ Maharashtra Industrial Development Corporation and Development Control and Promotion Regulations for Regional Plan areas in the State (hereinafter referred to as "the said Regulations");

In view of the facts and circumstances referred to above and in exercise of the powers conferred under Section 154(1) of the said Act, the State Government is pleased to issue the following revised directives in supersession of previous directives issued in this behalf and anything contained in the said Regulations.

## **DIRECTIVES**

Notwithstanding anything contained in the Govt. Orders dated 27<sup>th</sup> February 2009 and in the said Regulations modified from time to time by Government, henceforth the rates of premium to be levied for additional F.S.I. of Biotechnology buildings shall be as mentioned in the following table:-
