### NOTIFICATION

01. No.TPS-2913/1530/CR-279/2013/UD-30 :- Whereas, the Ambad Municipal Council (Dist. Jalna) (hereinafter referred to as "the said Muncipal Council"), being the Planning Authority for the area under its jurisdiction under Clause (19) of Section 2 of the Maharashtra Regional and Town Planning Act, 1966 (Maharashtra XXXVII of 1966) -(hereinafter referred to as 'the said Act'), has by its Resolution No.07/1, dated 29<sup>th</sup> July, 2007, made a declaration under Section 38 with sub-section (1) of section of the said Act of its intention to prepare the revised Development Plan for the entire area within its jurisdiction and notice of such declaration was published at Page No.29 in the Maharashtra Government Gazette (hereinafter referred to as "Official Gazette") Part 1, Aurangabad Division Supplement dated 27<sup>th</sup> December, 2007;

And whereas, Town Planning Officer appointed u/s 24 of the said act, after carrying out survey of the entire land within its jurisdiction, prepared existing land use map as required under Section 25 of the said Act and thereafter prepared the draft Development Plan of Ambad (Revised) handed it over to Muncipal Council Ambad for publication. The said Muncipal Council published a notice under section (1) of section 26 of the said Act to that effect at Page No 41, in the Official Gazette, Part 1- Aurangabad Division, Supplement, published Draft Development Plan;

And whereas, the Planning Committee appointed under section 28(2) of the said Act heared the suggestions and objections in respect of the aforesaid published Draft Development Plan received within the stipulated period:

And whereas, after receiving and considering the report of the Planning Committee, the said Planning Authority has submitted the said Draft Development Plan, without any modifications, under sub-Section (1) of section 30 of the said Act, on 24<sup>th</sup> July 2012 to the Government of Maharashtra for sanction;

And whereas, the said Act has been amended vide Maharashtra Act No. X of 2011 with effect from the 5th April, 2011,

And whereas, in accordance with the provisions of the subsection (1) of section 31 of the said Act, the State Government has to sanction the the said draft Development Plan within six months from the date of submission under section 30 of the said Act or within

such further extended time period not exceeding six months in aggregate as the State Government may specify;

And whereas, the Government has already published comprehensive 'Draft Development Control and Promotion Regulations for Municipal Councils and Nagarpanchayats in Maharashtra,' for suggestions and objections from the general public, vide notice No.TPS-1810/612/CR-2200/2010/UD-13, date 30th June 2011 under section 37 (1AA) of the said Act, and whereas this set of Draft Development Control Regulations shall also be made applicable to Ambad Municipal Council after due sanction from the Government.

And whereas, in accordance with sub- Section (1) of Section 31 of the said Act, the Government, after making necessary enquiries and after consulting the Director of Town Planning, Maharashtra State, Pune is of the view that it is necessary to sanction a part of the said draft Development Plan of the said Municipal Council, excluding:-

- (i) Draft Building Byelaws and Development Control Rules which shall be kept in abeyance; and
- (ii) Modifications of Substantial Nature which are required to be published under section 31(1) for inviting objections and suggestions from the general public.

Now, therefore in exercise of the powers conferred by Sub-section (1) of Section 31 of the said Act and all other powers enabling it that behalf, the Government of Maharashtra hereby—

- a) extends the period prescribed under Section 31(1) of the said Act for sanctioning the said Development Plan from  $23^{rd}$  January, 2013 up to and inclusive of  $22^{nd}$  July, 2013.
- b) sanctions the said Development Plan (Revised) for Ambad Municipal Council with the Schedule of Modifications appended hereto as "SCHEDULE A", excluding the substantial modifications shown on the said Development Plan as specified in " SCHEDULE B" of the Notice No. TPS-2913/1530/CR-279(A) /2013/UD-30 dated 22 <sup>nd</sup> July, 2013.
- c) keeps in abeyance the Development Control Regulations for the said Municipal Council as submitted under section 30 of the said Act by the said Planning Authority till the sanction of the draft 'Development Control and Promotion Regulations for Municipal Councils and Nagarpanchayats in Maharashtra', published by the Govt. under section 37 (1AA) of the said Act, on 30.06.2011 which will be made applicable as soon as the same are sanctioned by the Govt. u/s. 37(2) of the said Act.
- d) fixes the date after one month from the date of publication of this notification in the Official Gazette as the date when the final Development Plan for area of Ambad Municipal Council shall come into force.

- 02. Areas of reserved sites mentioned in the Report of the aforesaid sanctioned boundaries shown on the Final Development Plan.
- 03. The reservations/allocations/designations which do not appear in the Schedule- A aforesaid sanctioned Development Plan.
- 04. All the existing roads whether shown on plan or not, shall have the status of existing roads.
- O5. The private or rental premises designated in Public- Semipublic Zone shall continue to be in such zone as long as Public-Semipublic user exists, otherwise, such lands shall be considered to be included in the adjoining predominant zone.
- 06. Draftsman's errors which are required to be corrected as per actual situation on site or as per survey records, sanctioned layout, etc. shall be corrected by the Chief Officer. Ambad Municipal Council, Ambad, after due verification and with prior approval of the Director of Town Planning, Maharashtra State, Pune.
- 07. Those open spaces from sanctioned layouts that are earmarked as existing open spaces (in Green colour) on the aforesaid Development plan are subject to changes if respective layouts are revised. If the layout is revised and if open space is shown elsewhere in Residential Zone, then the existing open space in the layout as shown on the said Development Plan shall be treated as Residential Zone.
- 08. The developed areas within the flood line shown in blue lines on the Development Plan, are included in No-Development Zone. The existing user under these areas shall continue till its existence.
- O9. The aforesaid final Development Plan as sanctioned by the Government excluded the said Excluded Parts shall be kept open for inspection for the public during working hours on all working days for a period of one month, in the office of the Chief Officer, Ambad Municipal Council, Ambad, Dist. Jalna.
