## NOTIFICATION

Maharashtra Regional and Town Planning Act, 1966 No.D.P.Pauni(R)/TPV-2/4080

Whereas. Pauni Municipal Council (hereinafter referred to as "the said Municipal Council") by its General Body Resolution

No.3, dated 30th December, 1983 made a declaration under Section 38 read with Section 23(1) of the Maharashtra Regional and Town Planning Act, 1966 (Maharashtra Act No.XXXVII of 1966) (hereinafter referred to as "the said Act") of its intention to prepare a Revised Development Plan of the entire area within its jurisdiction which appeared in the Maharashtra Government Gazette Prot-I, Nagpur Division Supplement, dated 19th January, 1984 on page No.12: And whereas, the said Municipal Council, after carrying

out survey of the entire area within its jurisdiction, prepared and published a draft Development Plan of Pauni (Revised) (hereinafter referred to as the "the said Development Plan") on 17th March 1986 and published a notice to that effect in Maharashtra Government Gazette, Part-IA, Nagpur Division Supplement dated 20th March, 1986 on pages 9,10 in accordance with the provisions of sub-section (1) of Section 26 of the said Act;

the members of the public, modified the said Development Plan in accordance with the provisions of Section 28 of the said Act, submitted the said Development Plan as modified by it to the Director of Town Planning, Maharashtra State, Pune for sanction under sub-section (1) of Section 30 of the said Act, on 24th February, 1988;

And whereas, the said Municipal Council, after

considering the suggestions and objections received by it from

sub-section (1) of Section 31 of the said Act, the said Development Plan is required to be sanctioned not later than one year from the date of reciept of such plan from Planning Authority or within such further period as the State Government may decide; ....2/-
