the State Government by the Deoli Municipal Council.


2. Government desires that -

Whereas, the Deoli Municipal Council (hereinafter referred to as 'the said Municipal Council') by its resolution No.1 dated 1.7.81 made a declaration under sub-section (1) of section 23 of the Maharashtra Regional & Town Planning Act, 1966 ( Maharashtra Act No.XXXVII of 1966) (hereinafter referred to as 'the said Act') of its intention to prepare a revised development plan for the entire area within its jurisdiction as per the provisions contained in section 38 of the said Act ;

And whereas, the said municipal council after carrying out the survey of the said area prepared and published a draft development plan vide its resolution No.1 dated 6.3.82, notification of which appeared in the Maharashtra Government Gazette, Part-I-A, Nagpur Division Supplement dated 8.4.82 on pages 67 and 68 in accordance with the provisions of sub-section (1) of section 26 of the said Act ;

And whereas, the said municipal council after considering the objections and suggestions received by it in response to the plan published under section 26 decided to modify the draft development plan under section 28 of the said Act and submitted the draft development plan as modified by it to the State Government for sanction as per provisions of sub-section (1) of section 30 of the said Act;

And whereas, the Government of Maharashtra proposes to sanction the said draft development plan as submitted by the said municipal council without any modifications;

Now, therefore, in exercise of the powers conferred by sub-sec. (1) of section 31 of the said Act and all other powers enabling it in that behalf the Government of Maharashtra after consulting the Director of Town Planning, hereby -

- a) Extends the period under section 31 (1) for sanctioning the said draft development plan upto and inclusive of 23rd October, 1985.
- b) Sanctions the draft development plan without any modifications;  
30th December 1985.
- c) Fixes/to be the date on which the final development plan as sanctioned shall come into force.

NOTE : The aforesaid development plan as sanctioned shall be forwarded to the Deoli Municipal Council and it shall be kept open for inspection by the public in the office of the Deoli Municipal Council during office hours on all working days.

No. 1933-DP-KAT-MM - The Development Plan of Kamptee has been sanctioned by the Urban Development, Public Health and Housing Department, Maharashtra State, in two parts separately vide Resolution No. TPS-2471-23469-W-2, dated 15th June 1972 and No. TPS-2471-23469-W-2, dated 4th February 1975.
