The Maharashtra Regional & Town Planning Act, 1966
01. No. TPS-1612/522(N)/Recon. No.58/CR-103(A)/2012/UD-9: Whereas, the Shirdi Nagar Panchayat (Dist. Ahmednagar) (hereinafter referred to as "the said Planning Authority") being the Planning Authority within its jurisdiction under Clause (19) of section 2 of the Maharashtra Regional and Town Planning Act, 1966 (Maharashtra Act No. XXXVII of 1966) (hereinafter referred to as "the said Act") vide its Resolution No. 65, dated the 13th July, 2001 declared its intention under section 23, read with section 38 of the said Act to prepare draft Development Plan for the area within the Extended Limits of the Shirdi Nagar Panchayat (hereinafter referred to as "the said Development Plan") and notice of such declaration was published at page Nos. 1214 to 1215 in the Official Gazette, Nashik Division Supplement, Part-1, dated the 6th September, 2001;

And whereas, the Planning Authority failed to perform its duty imposed upon it under the provisions of the said Act, in taking required action under section 26, 28(4), 29 and 30 of the said Act for publication and submission of the said Development Plan of Shirdi (Extended Limits) to the Government for sanction within a specified time limit, because of which the Government of Maharashtra appointed the Deputy Director of Town Planning, Nashik Division, Nashik to be an Officer under section 162(1) of the said Act, (hereinafter referred to as "the said Officer") to exercise the powers and to perform the duties of the Shirdi Nagar Panchayat in terms of taking required action under section 26, 28, 29 and 30 of the said Act, regarding publication and submission of the said Development Pan of Shirdi (Extended Limits) to the Government for sanction vide the Urban Development Department's Notification NO. TPS-1610/571/CR-87/10/UD-9, dt. the 26th April, 2010;

And whereas, the said Officer published the said Development Plan under section 26 (1) of the said Act by issuing a public notice, which was published in the Official Gazette Part-1, Nashik Division Supplement, dt. the 20th January, 2011 to the 26th January, 2011, inviting suggestions / objections in respect of the said Development Plan, within the stipulated period of sixty (60) days from the date of the notice;

And whereas, the Plan showing the modifications made in said Development Plan, prior to its submission to the Government was published by the said Officer as per the provisions of section 28(4) of the said Act which appeared in the Official Gazette, Nashik provision Supplement Part-1, dated the 26th January, 2012 to the 1st February, 2012 on page Nos. 13 to 15;

And whereas, in accordance with the provisions of section 30 of the said Act, the said Officer submitted the said Development Plan along with Draft Development Control Regulations to the Government of Maharashtra for sanction on the 31st December, 2011;

And whereas, the said Act has been amended vide Maharashtra Act X of 2011 with effect from the 5th April, 2011;

And whereas, in accordance with the provisions of 31 (1) of the said Act, the State Government is required to sanction the said Development Plan within a period of six

months and within the extended period not exceeding six months in aggregate from the date of its submission under section 30 of the said Act;

And whereas, in accordance with sub section (1) of section 31 of the said Act, after making necessary enquiries and after consulting the Director of Town Planning, Maharashtra State, Pune the State Government has decided to sanction a part of the said Development Plan with modifications shown in SCHEDULE – A, excluding the substantial modifications (as EP-1, EP-2, ...) as specified in SCHEDULE - B and the Draft Development Control Regulations;

Now, therefore, in exercise of the powers conferred by sub section (1) of section 31 of the said Act and of all other powers enabling it on that behalf, the Govt. of Maharashtra hereby;

a) Extends the period of submitting the said Development Plan under section 30(1) of the said Act from 5th Oct. 2011 to 31st Dec. 2011.

b) Extends the period prescribed under section 31(1) of the said Act, for sanctioning the said Draft Development Plan upto and inclusive of the 30th December, 2012.

c) Sanctions the said Draft Development Plan for Shirdi Nagar Panchayat (Extended Limits) alongwith the Schedule of Modifications namely SCHEDULE - A appended hereto, excluding both, the substantial modification as specified SCHEDULE- B appended to Notice No. TPS-1612/522(N)/Recon.No.58/CR-103(B)/2012/UD-9, dated the 28th December, 2012 and the Draft Development Control Regulations.

d) Keeps in abeyance the Draft Development Control Regulations submitted along with the said Development Plan Report by the Shirdi Nagar Panchayat, till the sanction of "Development Control & Promotion Regulations for Municipal Councils and Nagar Panchayats in Maharashtra", which have already been prepared and published vide Govt. Notice No. TPS-1810/612/ CR-2200/2010/UD-13, dt. the 30th June, 2011 under section 37(1AA) of the said Act (hereinafter referred to as "the said Regulations"). The said Regulations shall be applicable after sanction of the Government for the area of the Shirdi Nagar Panchayat for which the said Development Plan has been prepared.

e) Fixes the date 15th February. 2013 as the date on which final Development Plan (Extended Limits) of Shirdi (excluding the excluded part) shall come into force.

02. The aforesaid final Development Plan of Shirdi Nagar Panchayat (Extended Limits), sanctioned by the Government shall be kept open for inspection by the public during office hours on all working days for a period of 1 month from the date of coming into force of this notification in the office of the Chief Officer. Shirdi Nagar Panchayat. Dist, Ahmednagar.

03. The reservations / allocations / designations which do not appear in the Schedules A and B are hereby sanctioned for the respective purpose as designated in the Development Plan.

04. Areas of reserved sites mentioned in the report of the Development Plan are approximate and subject to actual measurement on site as per boundaries shown on the Final Development Plan.

05. The Private or rental premises designated in Public - Semipublic Zone will continue to be in this zone as long as Public-Semipublic user exists. Otherwise the Chief Officer, Shirdi Nagar Panchayat, Dist, Ahmednagar shall allow development permission on such lands considering adjoining major land use zone after due verification and with prior approval of the Director of Town Planning, Maharashtra State, Pune.

06. Draftsman's error which is required to be corrected as per actual situation on site / or as per survey records, sanctioned layout etc. shall be corrected by the Chief Officer, Shirdi

Nagar Panchayat, Dist, Ahmednagar after due verification and prior approval from the Director of Town Planning, Maharashtra State, Pune.
