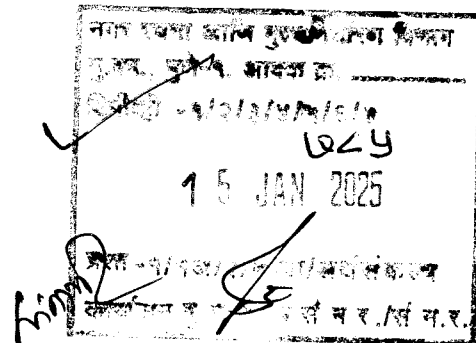

MAHARASHTRA REGIONAL & TOWN PLANNING ACT, 1966

No. TPS- Pandharpur no.1/Extn/section 61/42

Whereas, the Municipal Council, Pandharpur (being the Planning Authority) (hereinafter referred to as 'the said Municipal Council') in exercise of the powers vested in it under sub-section (1) of section 60 of the Maharashtra Regional & Town Planning Act, 1966 (Maharashtra Act no. XXXVII of 1966) (hereinafter referred to as 'the said Act') by its Resolution No.382 dated 22.09.2023, declared its intention to prepare the Draft Town Planning Scheme Pandharpur, (hereinafter referred to as 'the said draft scheme') for the area comprised in that scheme and published the declaration so made in accordance with the provisions of sub-section (2) of section 60 of the said Act in the Maharashtra Government Gazette 12 to 18 Oct, 2023, at page no. 4&5;

And whereas, in accordance with the provisions of sub-section (1) of section 61 of the said Act, the said Municipal Council has to make and publish the said draft scheme not later than Nine months from the date of declaration of intention to prepare the **said draft scheme** excluding Code of Conduct period. i.e. within such further period as may be extended by the Government, under the provisions of sub section (3) of section 61 of the said Act;

And whereas, the said Municipal Council by its letter no.171, dated 09.01.2025 has requested the Joint Director of Town Planning, Pune Division, Pune to extend the period for preparing and publishing the **said draft scheme**, under the provisions of sub-section (3) of Section 61 of the said Act, by a further period of three months from 09.11.2024 to 09.02.2025;

And whereas, it is expedient to extend the period for preparation and publication of the **said draft scheme** by a period of three months from 09.11.2024 to 09.02.2025 in the larger public interest;

Now, therefore, in exercise of the powers delegated to him under the Government Notification in Urban Development Department, No. TPS -1813/3211/C.R.508/UD-13, dated.01.12.2016 and all other powers enabling it in that behalf, the Joint Director of Town Planning, Pune Division, Pune is hereby pleased to extend, under sub-section (3) of Section 61 of the said Act, the period for preparing and publishing the said draft scheme by a further period of three months from 09.11.2024 up to and inclusive of 09.02.2025.
