Maharashtra Regional and Town Pla Ing Act<sub>v</sub>1966 No.TPS 1772/24613-W-II: Whereas the Akkalkot Municipal lity constituted under the Bombay District Municipal Act, 1901, (hereinafter referred to as the said Municipality) by its resolution No.3, dated 8th September, 1964, made a declaration under sub-section (1) of section 4 of the Bombay Town Planning Act, 1954 (Bom. AXVII of 1955) (hereinafter referred to as the "said Bombay Act") of its intention to prepare a Development Plan for the entire area within its jurisdiction;

And Whereas, since the 15th day of June, 1966 the said Municipality has been replaced by the Akkalkot Municipal Council (hereinafter referred to as "the said Municipal Council") under the Maharashtra Municipalities Act, 1965 (Mah.XL of 1965);

And Whereas since the 11th day of January 1967
the said Bombay Act has been replaced by the Maharashtra
Regional and Town Planning Act, 1966 (Mah. AKAVII of \$966)
(hereinafter referred to a the "said Maharashtra Act");
and accordingly, in pursuance of the provisions of
Section 165 of that Act, the declaration of intention
to prepare a Development Plan is deemed to have been
made by the said Municipal Council under the corresponding provisions of the said Maharashtra Act and the
provision of that Act a shall b have effect in relation
thereto;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 31 of the said Maharashtra Act and T all other powers enabling it in this behalf, the Government of Maharashtra, after consulting the Director of Town Planning, hereby - (à) sanctions the said Development Plan with the modification specified in the Schedule heretp, and

(b) fixes the 16th day of July 1973 to be the date on which the final Development Plan as sanctioned shall come into force.

## SCHEDULE

## MODIFICATION TO THE DEVELOPMENT PLAN OF AKKALKOT

In the Regulation controlling the use and Development of the lands under the Development Plan of Akkalkot regulation under Part X shall be deleted.

NOTE: The aforesaid Development Plan as sanctioned by Government shall be forwarded to the Akkalkot Municipal Council and shall be kept open for the period of one year for inspection by the public at all reasonable hours in the office of the said Municipal Council.
