No.TPS 2287/1081/CR-182/UD-9 .- Whereas, the Development Plan of Chandrapur, has been sanctioned vide Government in Urban Development and Public Health Department Resolution No.TPS-2275/639/UD-6, dated 3rd August, 1976 and has come into force with effect from 1.10.1976 (hereinafter referred to as "the said Development Plan");

And whereas, in the said Development Plan the land admeasuring about 0.02 hectares out of Sheet No.14, Block No.48, Jhanapeth is reserved as Site No.114 "Open Space";

And whereas, the Chandrapur Municipal Council, being the Appropriate Authority, is satisfied that, Site No.114 "Open Space" is not required for the Public purpose and has requested the State Government to delete the Site No.114 "Open Space" from the said Development Plan, vide its letter No.1019/92, dated 4th March 1992;

And whereas, Government after making necessary inquiries is satisfied that, the site No.114 "Open Space" is no longer necessary for the said public purpose in the public interest ;

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 50 of the Maharashtra Regional and Town Planning Act, 1966 and all the powers enabling it in that behalf; Government hereby sanctions the proposal of deletion of Site No.114 "Open Space" from the said Development Plan and for that purpose amends the Government Notification No.TPS-2275/639/UD-6, dated 3rd August 1976 as follows viz :-

: 2 :

In the Government Notification, in the Schedule of modifications appended to the Notification sanctioning the said Development Plan, after the last entry, the following new entry shall be added, viz :-

" Site No.114 "Open Space" is deleted from the reservation as shown in mauve verge on the part plan of Development Plan of Chandrapur bearing No.DP-Chandrapur/TPV-2/3619".

Note :- The aforesaid part plan is kept open for inspection by the public during office hours during all working days in the Office of the Chandrapur Municipal Council, Chandrapur for a period of one month.

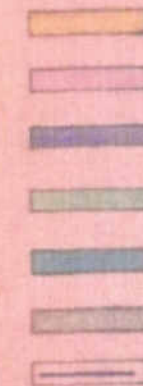
