THE MAHARASHTRA REGIONAL & TOWN PLANNING ACT 1966

01. NO. TPS -2212/521(N)/Reco.No. 57/CR-102(A)/2012/UD-9: Whereas, Warora, Municipal Council, (Distt. Chandrapur) (hereinafter referred to as the "said Planning Authority"), being the Planning Authority within its jurisdiction under clause (19) of section 2 of the Maharashtra Regional and Town Planning Act, 1966 (Maharashtra XXXVII of 1966) (hereinafter referred to as "the said Act"), vide its Resolution No. 24, dated the 21th December, 1999 had declared its intention under section 23(1), read with section 38 of the said Act to prepare and revise Draft Development Plan for the area within the original limits of the Warora Municipal Council (hereinafter referred to as "the said Development Plan") and notice of such declaration was published at page nos. 85 and 86 in the Official Gazatte, Nagpur Divisional Supplement, dated the 14th June, 2001;

And whereas, the said Planning Authority had appointed the Town Planning Officer for preparing the Draft Development Plan and whereas, after carrying out survey of the entire area within the area of intention declared as required under section 25 of the said Act, the Town Planning Officer prepared the Draft Development Plan and submitted the same to the Warora Municipal Council for publication under section 26 (1) of the said Act and further necessary action;

And whereas, the said Planning Authority published the said Development Plan under section 26(1) of the said Act by issuing a public notice, which was published in the Official Gazette, Nagpur Divisional Supplement, dated the 14th January, 2010 on page no. 4 inviting suggestions and objections in respect of the said Development Plan, within the stipulated period of 60 (sixty) days from the date of the above said notice;

And whereas, after considering the suggestions and objections received in respect of the published Draft Development Plan, the Planning Committee set up under section 28(2) submitted its report to the said Planning Authority and whereas the said Planning Authority, vide Resolution No. 5, dated the 2nd September, 2011 made certain modifications in the said Development Plan under sub section (4) of section-28 of the said Act;

And whereas some of the modifications proposed by the Planning Authority were republished at page nos. 543 to 546 in the Official Gazette, Nagpur Divisional Supplement, dated the 15th December, 2011 for public information;

And whereas, in accordance with the provisions of sub section (1) of section 30 of the said Act, the said Planning Authority has submitted the said Development Plan to the Government of Maharashtra for sanction vide letter No. 464/2011, dt. the 29th December, 2011;

And whereas the said Act has been amended vide Maharashtra Act X of 2011 with effect from the 5^{th} April, 2011;

And whereas the Director of Town Planning, Maharashtra State, Pune has extended the period for submitting the said Development Plan under section 30(1) of the said Act, upto and inclusive of the 29/12/2011 under the powers delegated to him vide Govt. Notification No. TPV-1086/3791/CR-103/1/87/UD-17, dt. the 5th January, 1987,

And whereas, in accordance with the provisions of section 31(1) of the said Act, the State Government has to sanction the Draft Development Plan within six months or within the extended time period not exceeding six months in aggregate from the date of its submission under section 30 of the said Act;

And whereas, in accordance with subsection (1) of section 31 of the said Act, after making necessary enquiry and after consulting the Director of Town Planning, Maharashtra State, Pune, the State Government has decided to sanction a part of the said Development Plan modification, as specified in SCHEDULE-A (as M-1, M-2,-----), excluding both, the substantial modifications (as EP-1, EP-2 etc.) as specified in SCHEDULE-B and the Draft Development Control Regulations;

Now, therefore, in exercise of the powers conferred by sub section (1) of section 31 of the said Act and of all other powers enabling it on that behalf, the Govt of Maharashtra here by:-

- a) Extends the period prescribed under section 31(1) of the said Act, for sanctioning the said Development Plan upto and inclusive of the 28th December, 2012.
- b) Sanctions the said Development Plan for Warora Municipal Council along with a schedule of modification, namely SCHEDULE-A appended here to, excluding both, the substantial modification as specified SCHEDULE-B and the Draft Development Control Regulations.
- c) Keeps in abeyance the Draft Development Control Regulations submitted along with the said Development Plan Report by the Warora Municipal Council, till the sanction of the Development Control and Promotion Regulations for Municipal Councils and Nagar Panchayat in Maharashtra which have already been prepared and published vide Govt. Notice No. TPS-1810/612/CR-2200/2010/UD-13, dt. the 30th June, 2011 under section 37(1 AA) of the said Act (hereinafter refered to as "the said Regulations") the said Regulation shall be applicable After the sanction of the Government, for the area of the Warora Municipal Council for which said Development Plan has been prepared.
- d) The Final Development Plan (Part) for area of Warora Municipal Council shall come into force after 30 days from the date of publication of this Notification in the Official Gazette.
- **02.** The reservations/allocations/designations which do not appear in the Schedule A and B are hereby sanctioned for the respective purposes as designated in the Development Plan.
- 03. Draftsman's errors which are required to be corrected as per actual situation on site/or as per survey record, sanctioned layout etc. shall be corrected by the Chief Officer, Warora

Municipal Council, District Chandrapur after due verification and with prior approval of the Deputy Director of Town Planning, Nagpur Division, Nagpur.

- 04. The private or rental premises designated in public-semipublic zone will continue to be in such zone as long as public, semipublic user exists; otherwise those lands shall be considered to be included in the adjoining major use zone.
- 05. The aforesaid part final Development Plan sanctioned by the State Govt. shall be kept open for inspection by the publice during office hours on all working days for a period of one month from the date of coming into force of this notification, in the office of the Warora Municipal Council
